We are excited to share this Impact Report with you! It is a celebration of all that you made possible in 2025. Because of your support, the DLC reached remarkable milestones, and we are deeply grateful to you for helping us achieve so much.

Thanks to you and the vision and partnership of six landowners, 1,000 acres of working farmland, forests, wetlands, and scenic landscapes were permanently protected. With these additions, the DLC

has now conserved more than 48,000 acres. That's the equivalent of 36,000 football fields! As our natural resources grow ever more limited, we remain committed to doing even more. Our next major milestone is within reach: 50,000 acres protected forever!

In 2025, you enabled us to continue our work stewarding the lands of the Jesse and Gayle Bontecou Wildlife Conservation Preserve, helping to shape it into a vibrant learning landscape. Its trails welcome the local community to visit a local landscape we all hold dear. Through a wide array of educational and volunteer activities held at the preserve, people have been invited to explore this wonderful wildlife sanctuary and working farm. We are profoundly grateful to everyone who has contributed to the Preserve Fund and helped to bring this longheld dream to life.

You helped to bring nearly 2,000 people of all ages together to clear invasive plants at the Bontecou Preserve, improve trails at the Seven Wells

Preserve, and learn about topics like deer fencing installation, soil testing and native seed sowing. The enthusiasm, curiosity, and smiling faces they brought were a powerful reminder of why this work matters.

Because of you, we now have more than 450 easement landowners who share our commitment to caring for conserved land, and with their blessing, we walked over 500 miles and flew over tens of thousands of acres to monitor compliance with the conservation easements entrusted to us. This essential stewardship responsibility is one we proudly uphold every year, now and forever.

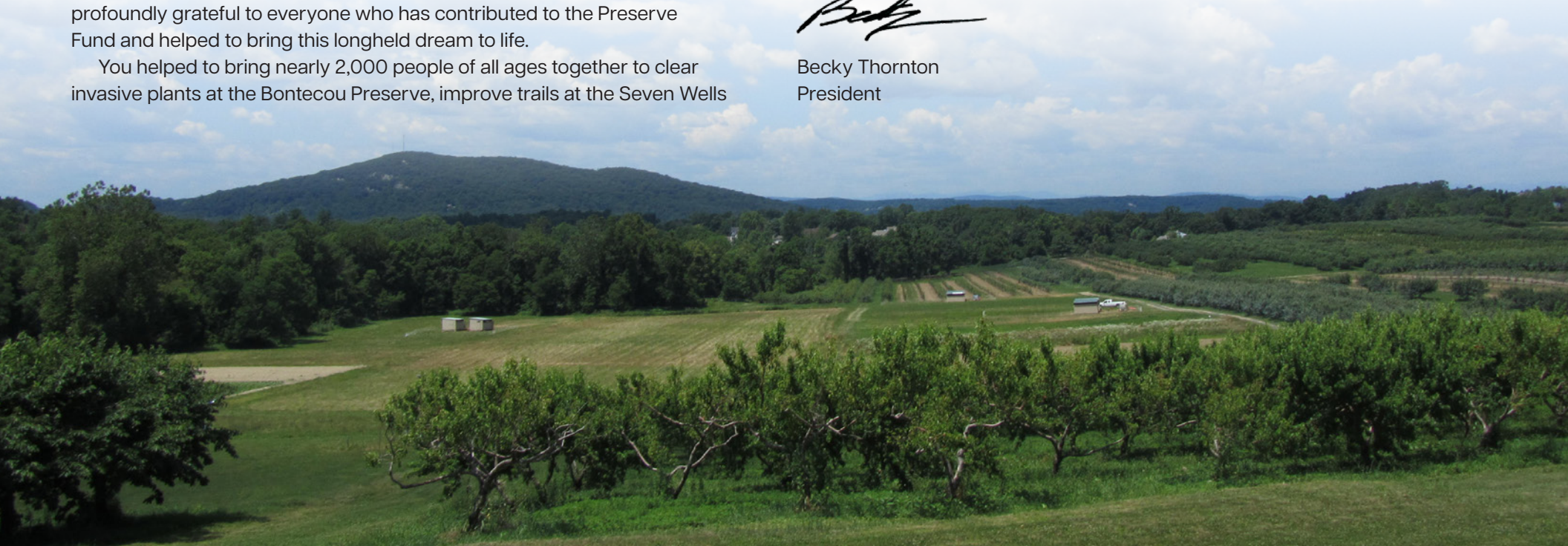

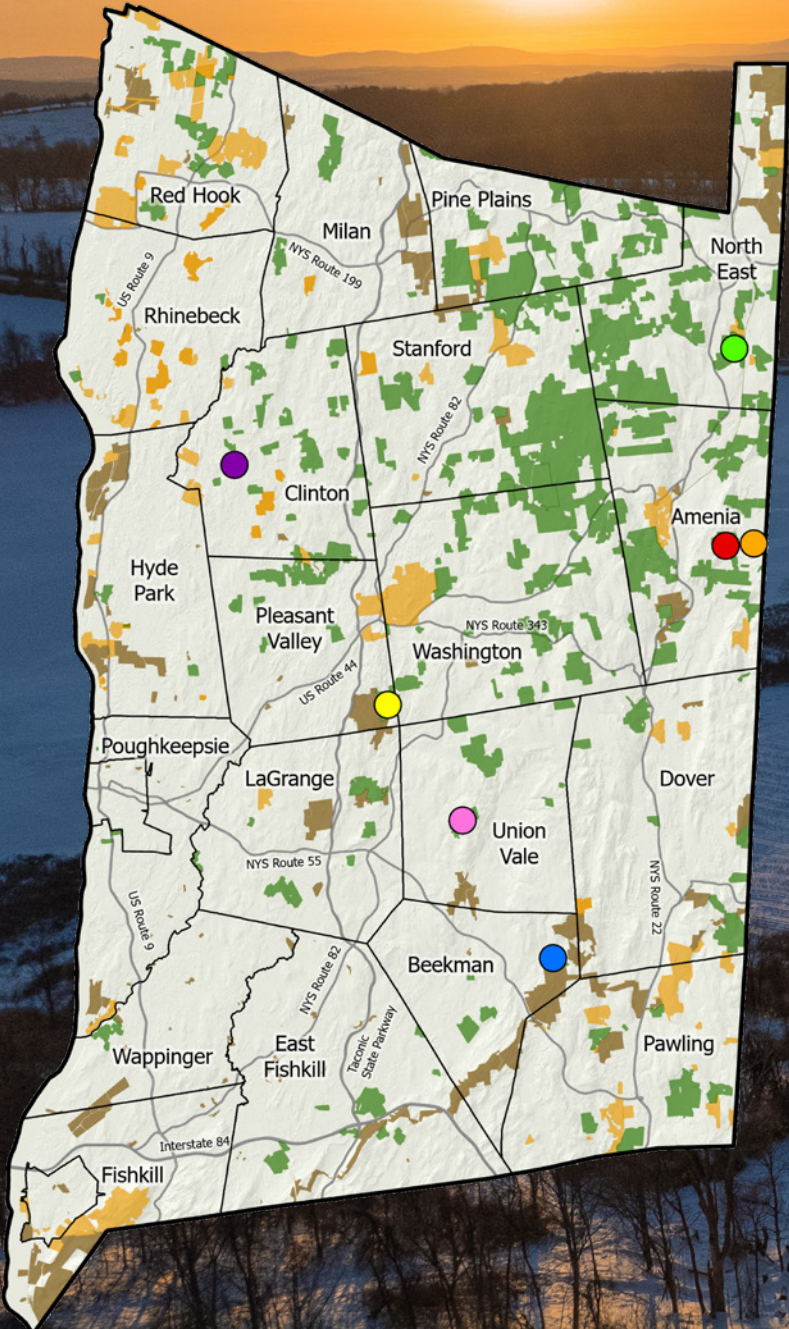

CONSERVATION CHARACTERISTICS:

- 2,900 acres of DLC-protected land within a three-mile radius
- Scenic vistas of the Harlem Valley and Rattlesnake Ridge
- Within the Ten Mile River watershed
- Vast tracts of core forest of special importance for sensitive wildlife
- Wide variety of habitats, including pastureland, woodland, fens, wetlands, and streams

128 acres, North East

CONSERVATION CHARACTERISTICS:

- Large contiguous forest that abuts other DLC-protected and forested land
- More than 3,800 acres of DLC-protected land within a three-mile radius
- Within the Ten Mile River Watershed
- Expansive meadows, important habitat for grassland birds, pollinators, and small mammals
- Crucial wildlife corridor for forest birds, large mammals, reptiles, and amphibians

CONSERVATION CHARACTERISTICS:

- Conserved by owners and gifted to Innisfree Garden
- Preserves the viewshed from Innisfree Garden
- Protects eastern shore of Tyrell Lake
- Near more than 5,000 acres owned by NYS and other local institutions
- Federally designated wetlands and vernal pools
- Rare circumneutral bog lake
- Preserves 2,000 feet of Sprout Creek

CONSERVATION CHARACTERISTICS:

- Borders on Appalachian Trail National Park Land corridor
- One of first easements in nation partially funded through the Appalachian Trail Conservancy's Wild East Action Fund
- Protects half-mile of Gardner Hollow Brook
- Conserves expansive woodlands at meeting point between northern and southern Appalachian forests
- Historical land in use dating back to the American Revolution
- Preserves small historic cemetery

CONSERVATION CHARACTERISTICS:

- Working Christmas tree farm, haying, and agroforestry operation
- Historic heritage farm owned by six generations dating back to 1810
- Preserves headwaters of Crum Elbow Creek
- 13 acres of freshwater wetlands
- Situated among many small local farms in the area

- Native grasslands in the process of being restored on the property
- Important habitat and wildlife corridor for forest and grassland birds, mammals, reptiles, amphibians, and pollinators

The DLC's Perpetual Responsibility: Stewardship of its Protected Land

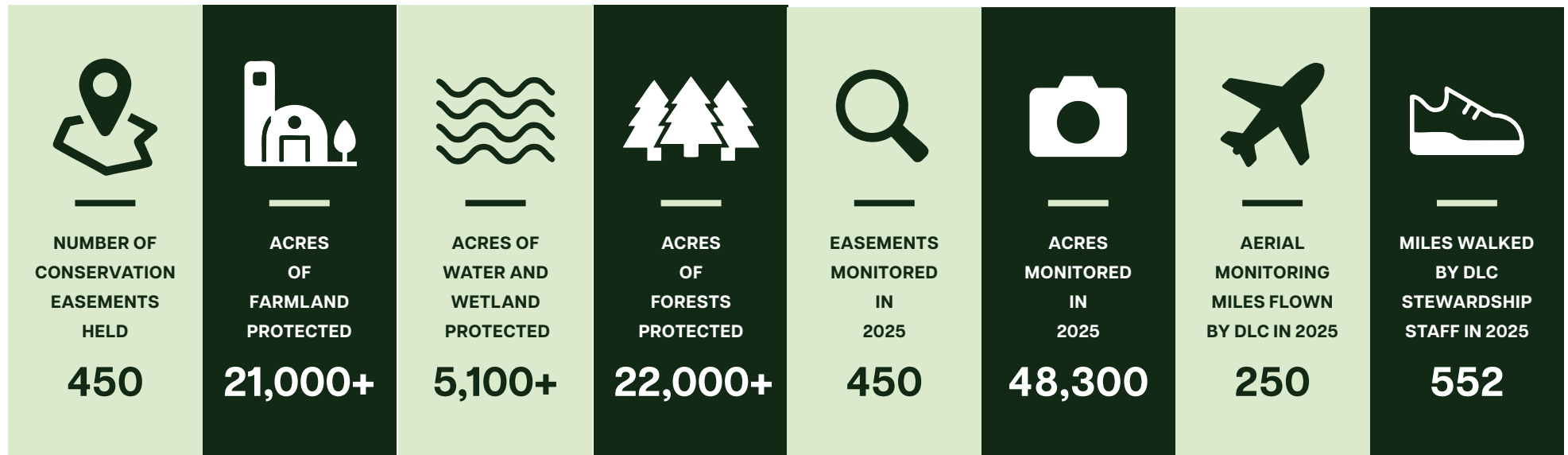
As the number of conservation easements under the DLC's care continues to grow, so does our enduring commitment to support landowners in the longterm stewardship of their protected properties. We are proud to partner with more than 450 environmentally minded stewards who own and thoughtfully care for land safeguarded by conservation easements.

The Jesse and Gayle Bontecou Wildlife Conservation Preserve, which opened to the public in October 2024, has welcomed hundreds of visitors exploring both the Lake and Vista trails. Thanks to the generosity of our dedicated supporters, we have raised \$2.8 million toward our \$3 million Preserve Fund goal.

We are continually refining the Preserve's management plan using insights from new studies, while our devoted volunteers work to remove invasive plant species, protect native species, and conduct valuable community science. Their efforts are helping to ensure the Preserve becomes a lasting resource for education and sustainable land management for generations to come.

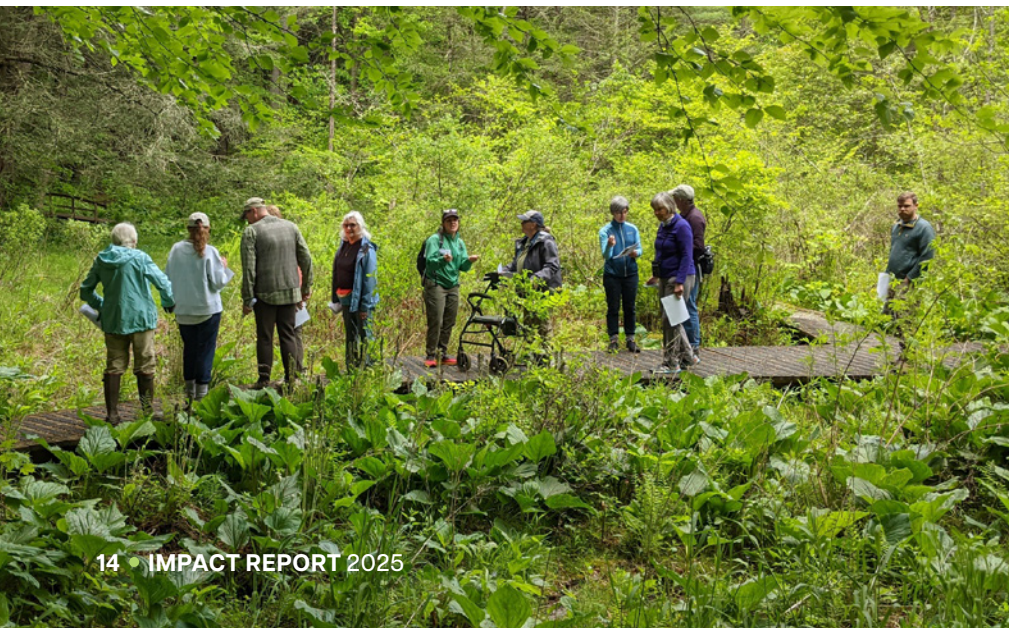

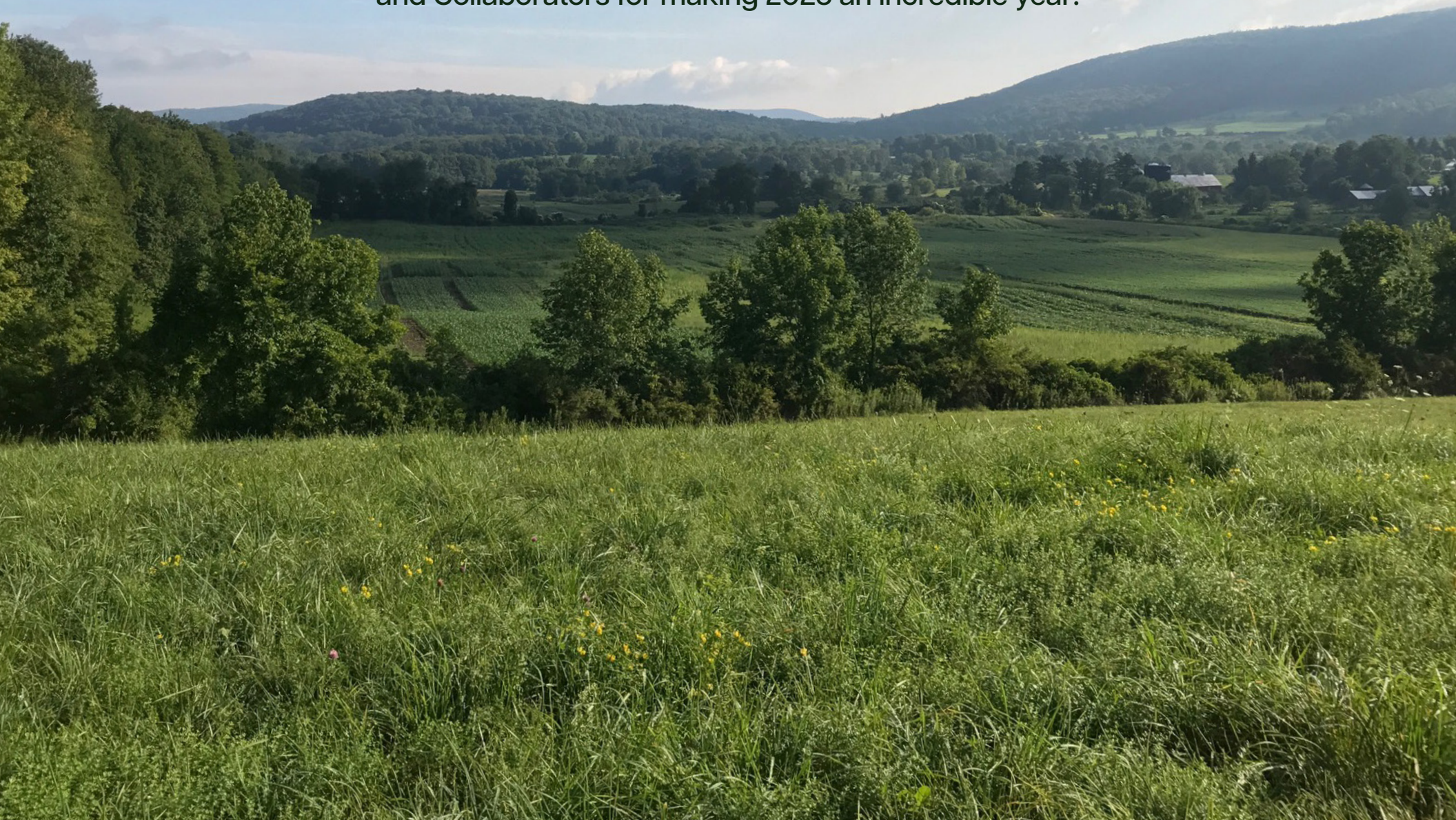
